INDEMNITY



Acknowledgment and Assumption of Risks, Dangers and Obligations

I acknowledge that Motor Cycle Racing is dangerous and that by engaging in the riding of motor cycles as part of the Coastal Motorcycle Club W.A. Inc or by attending at the premises at Coastal Motorcycle Club W.A. Inc I am exposed to certain risks and dangers and under certain obligations which risks and dangers and obligations I accept and participate in at my own risk. The risks, dangers and obligations include but are not limited to:

- (a) I may be injured, physically or mentally and may be killed;
- (b) That my property including machinery or equipment may be damaged lost or destroyed;
- (c) That other riders may ride dangerously or with lack of skill;
- (d) That the conditions may be hazardous and may vary without warning and predictability;
- (e) That any policy of insurance or in respect of my life or physical or mental health may be void;
- (f) That there may be no or inadequate facilities for treatment and transport of me if I am injured;

Contract Excluding Liability

In consideration of the acceptance of me as a member of the Coastal Motorcycle Club W.A. Inc I agree to absolute and release from all liability the Coastal Motorcycle Club W.A, Inc, its members, servants or agents and the authorities which own occupy or manage the land on which motor cycle riding is to take place for any injury or damage to myself or my property arising out of participation in or as observer to motor cycle riding due to any negligent act, breach of duty, default and /or omission on behalf of the Coastal Motorcycle Club W.A. Inc, their members, servants or agents or on part of any of the persons or authorities who own, occupy or manage the land on which the motor cycle riding is to take place, I further acknowledge:

- 1) That I am a member and attend at the Coastal Motorcycle Club W.A. Inc at my sole risk and sole responsibility;
- 2) That I accept the property as it stands with all or any defects hidden or exposed;
- 3) That I will ride in a manner, which is safe, and with all due care and attention.

KEY / CLUB RULES



1. YOUR MEMBERSHIP CARD AND MWA LICENCE ARE TO BE CARRIED AT ALL TIMES AT THE TRACK.
2. ALL MEMBERS ARE REQUIRED TO ATTEND THREE (3) BUSY BEES THROUGHOUT THE YEAR WITH A MINIMUM OF 2 HOURS AT EACH BUSY BEE.
3. EACH MEMBER WILL BE PLACED ON THREE ROSTERS FOR ASSISTANCE AT BUSY BEES AND OPEN EVENTS THROUGHOUT THE YEAR. ALL RIDERS AT CLUB RUNS WILL BE EXPECTED TO DO SOMETHING
4. THE GATE AND AREA AROUND THE TOP CANTEEN ARE UNDER 24 HOUR CAMERA SURVEILLANCE. IF YOU LEAVE THE GATE OPEN YOU WILL HAVE YOUR GATE KEY TAKEN FOR FOUR WEEKS. IF THIS OCCURS AGAIN YOUR KEY WILL BE TAKEN FOR THE REMAINDER OF YOUR MEMBERSHIP.
5. THE GATE MUST BE KEPT LOCKED AT ALL TIMES.
6. MEMBERS ARE NOT PERMITTED TO BRING NON-MEMBER RIDERS TO THE TRACK TO RIDE.
7. ALL RIDERS AND OFFICIALS MUST SIGN ON AT THE 'SIGN-ON' SHED BEFORE ENTERING THE TRACK AREA.
8. RIDING ON THE TRACK ONLY, ALL RIDERS MUST TRAVEL IN A COUNTER CLOCKWISE DIRECTION.
9. NO CUTTING OF THE TRACK. THESE AREAS ARE NOT LICENCED AND ARE USED FOR CLUB VEHICLES ONLY.
10. ALL OFFICIALS TO ENSURE 50cc, QUADS, JUNIORS AND SENIORS HAVE SEPERATE PRACTICE SESSIONS, AS PER MWA PERMIT CONDITIONS.
11. NO ONE AT ANY TIME IS PERMITTED TO RIDE OUTSIDE OF THE TRACK OR PIT AREA.
12. IT IS YOUR RESPONSIBILITY TO CHECK THE TRACK FOR DAMAGE, DEBRIS OR ANY DANGER TO YOURSELF OR YOUR MACHINE PRIOR TO RIDING.

14. NO DOGS PERMITTED AT THE TRACK.
15. RESPECT ALL OFFICIALS AND OTHER MEMBERS, AS THEY HAVE YOUR BEST INTEREST IN MIND.
16. DUMPING OF RUBBISH IS PROHIBITED; PLEASE TAKE YOUR OLD TYRES AND USED OIL ETC HOME.
