 - Approved helmet, goggles, riding pants, boots, long sleeved top
 - Juniors require body armour in addition to the above.
- New senior riders will also need to undertake an official accreditation with one of our accreditation officers. (Competition Licence only - phone to make an appointment)
- **All new juniors (under 16) who require a Competition Licence will need to complete 5 hours of coaching before being issued with a National Licence.**

All Members will be required to take out a Licence with Motorcycling WA.
